SUMMER CAMP 2026 TERMS, POLICIES & WAIVER

(THE FOLLOWING WAIVER/CONSENT FORM IS WHAT PARENTS AND GUARDIANS WILL SEE AND HAVE TO ACCEPT BEFORE GOING TO FINALIZE PAYMENT AND SECURE THE WEEK (S) SUMMER CAMP)

GENERAL CONSENT:

SRA Management Group, LLC d/b/a The Adirondack Club has my permission for the following:

- To transport my child to Summer Camp and Adirondack Club activities using licensed and insured transportation.
- To obtain emergency medical treatment for my child in the event I cannot be reached.
- To use photos/videos of my child for promotional and educational purposes.

UNDERSTANDING OF CANCELATION & REFUND POLICIES:

- The Adirondack Club will refund paid tuition minus the \$75.00 Deposit per week if The Adirondack Club receives the notification of the desire to cancel in writing via mail by the end of business on April 8, 2026. (email is acceptable if the email falls within the above guidelines)
- After April 8, 2026, refunds will only be considered for qualifying documented medical reasons confirmed by a physician in writing.
- Ongoing "pandemic concerns" are NOT a qualifying medical reason for a refund.
- There are no refunds or credits for missed camp day/weeks.

TERMS AND CONDITIONS OF ENROLLMENT

By continuing you understand and accept the <u>Terms and Policies of Camp</u>
<u>Enrollment</u> put in place by SRA Management Group, LLC d/b/a The Adirondack
Club which include the following:

- The Adirondack Club reserves the right to dismiss any camper whose conduct is deemed detrimental to the overall good of the Camp. In cases of gross misconduct, no refund will be provided. No refunds or credits will be provided for late arrivals or early departures.
- The Adirondack Club maintains the highest safety standards; however, it does not assume liability for accidents, illness or the transmission of disease or viruses.
- This Camp must comply with the regulations of the Massachusetts
 Department of Public Health (105 CMR 430 and the Franklin Department of Public Health.)
- It is hereby understood and agreed that any accident or illness claim will be covered by the Parent's or Guardian's health insurance.
- Any camper attending Summer Camp at The Adirondack Club will be required to have an updated physical on file before attending Summer Camp. This physical must comply with the regulations of the Massachusetts Department of Public Health (105 CMR 430 and the Franklin Department of Public Health.)
- The Adirondack Club will make a good faith effort to deliver Camp Services as stated above as well as in promotional literature and online content; however, in the event of circumstances outside our control (for example: pandemic, virus, natural disaster, venue changes) impacting our ability to deliver these services, we are not responsible for the outcome of these services as a result of necessary changes/modifications. The Adirondack Club is committed to the safety and wellness of our campers and staff at all times.
- By completing the enrollment process, you acknowledge that you have read, understood, and agree to all the terms outlined in this waiver and consent form.

ENROLLMENT & DISCOUNT POLICIES

1. Multi-Week Discount

The 5% discount with purchase of 6 or more weeks is exclusively available for campers who are directly related (siblings) and live at the same address. This discount applies only when these criteria are met, and all siblings are enrolled under the same account.

2. Enrollment Rules

- Only a camper's parent or legal guardian may complete their enrollment.
- Enrolling a camper under an account that does not belong to their parent or legal guardian will result in immediate disqualification from the program.

3. Policy on Disqualified Enrollments

- If a camper is disqualified due to a violation of the above policies, their weeks will be immediately refunded, and they will be removed from all registered weeks.
- For any weeks with a waitlist, the next person on the waitlist will automatically be enrolled, and the disqualified camper's spot will not be saved.
- Families wishing to re-enroll after disqualification must join the waitlist for any desired weeks and will be subject to availability at the time.

4. Adirondack Club Family Membership Discount

- Applies to campers who are part of an active, in good standing, "Family Membership" with The Adirondack Club while attending camp
- Use the discount code sent via email (last week of December) or contact the children's services department
- If your family membership is not active prior to the start of your purchased summer camp weeks, then you will be charged the nonmember price.
- No other Adirondack Club membership types are eligible for the discount

5. Installment/Payment Options

 When completing your registration, you have the option to pay it in full or choose the installment payment option

- The installment payment will charge you at the time of checkout for the \$75/week deposit plus any add-ons in your cart. It will then charge the remaining balance on 4/15/26
- If you are planning to get a family membership before 4/15/26 please pay the deposit at checkout and contact the children's services department by 4/8/26 to modify the scheduled payment
- Due to the limitations of the software we use, the installment payments will charge the credit card for each week in the order, not as a lump sum
